

Reminder, Reminder: Absentee ballots need to be requested by Monday February 3, 2020 by 5pm

Brothers and Sisters,

Nominations for the President and Stewards has closed. The election will be held on Tuesday, February 11, 2020 from 11:30am-2pm at Westfall Rd, Saint Paul St and CSEU offices. Members at all other locations will need to request absentee ballots following directions below. If a race is uncontested, elections will be by acclamation of the members present at the nomination/membership meeting on January 23, 2020. In a contested race for President where the winner does not receive at least 50% + 1 of the ballot cast, a runoff election will be held between the two (2) candidates with the most votes. Runoff voting will occur on February 27, 2020 from 11:30 am – 2pm at Westfall Rd, Saint Paul St. and CSEU offices. All other locations will vote by absentee ballot due by February 24<sup>th</sup>.

Members in good standing are eligible to vote in the elections. If you will be out of work on the day of the vote (or at other locations other than Saint Paul St, Westfall Rd or CSEU) you may request an absentee ballot at <u>message@fsw-</u> <u>union.org</u>, no later than 5:00pm on Monday, February 3, 2020, and the ballots must be completed and returned no later than 5:00pm on Friday, February 7<sup>th</sup>, 2020.
