What was the purpose of the function? There were various workshops / seminars/ and panel discussions on various topics such as: "The Janis Era -How we got here, how we got ready, and the Challenges Ahead" I found to be very interesting and very informative. What did you learn and/or what significant information was shared at the function?

I attended 2 workshops: Organizing & Strategic Planning and Runaway & Inequality.

Runaway & Inequality - I was somewhat taken back when I was given the information on the salaries that Presidents & CEOs are earning versus the amount that the employees are earning, more than 100% +. Which I found to be very dishearten and disappointing.

There was a lot of information that was shared such as: All the successes that New Jersey has achieved since electing governor Murphy (now that Gov. Christy is no longer in office) in a very short length of time. Which is very impressive.

There were discussions on how to response to questions that we may be asked in the future due to the passing of Janis. They spoke about how Janis came about and the reason why persons believed it would be a good idea to get rid of the unions as well as what would happen without unions.

There were presentations such as: CWA District Report, Credentials Reports, CWA Member and Non-Member Polling, and Avoiding Financial Fraud Presentation.
